

Koninklijke Nederlandse Pharmaceutische Studenten Vereniging Secretarial Report of the Congress GA of the K.N.P.S.V. Held on May 13th, 2021

During the General Assembly (GA), the Board made five proposals. All proposals were accepted. The first proposal concerned the list of resolutions. One decision was removed from the list of resolutions. The decision regarding the society recognition Ph.V.D. "Hygeia" was removed from the list of resolutions, because this resolution is included in the internal regulations. The second proposal concerned the addition of the Activities Committee and the removal of the Future and Education Perspectives Committee from the committee roster of the K.N.P.S.V. The third proposal concerned the Activities Committee regulations were amended because part of the regulations overlapped with the Covenant. In addition, an incorrect numbering was adjusted. The fourth proposal concerned the five-year plan. The five-year plan of the K.N.P.S.V. will take effect from May 13th, 2021. The fifth proposal concerned the purchase of a new secretary's laptop.

Furthermore, the policy plan of the board was reviewed and both the five-year plan and the annex to the five-year plan were approved. In addition, the gift to the association was unveiled: a tug-of-war rope.

The annual reports of the board and the permanent committees were considered and approved. In addition, the commissioner of foreign affairs provided an update on the Student Exchange Program (SEP), the International Pharmaceutical Students' Federation (IPSF) World Congress in Seoul, and the European Regional Symposium. SEP has been cancelled for incoming students. However, three Dutch students will go abroad for an internship in the summer of 2021. The IPSF World Congress will take place online from the 22nd of June to the 1st of August. Registrations are now closed as the maximum number of participants has been reached. The European Regional Symposium will also take place online from July the 14th to the 18th. Here, in addition to workshops and educational activities, a number of social activities will be organized, such as an international night and a gala night.

The commissioner of general affairs provided an update on European Pharmaceutical Students' Association (EPSA), the TWIN, the Stipendia Fund and the promotion. The EPSA Annual Congress 2020 has been moved to the fall of 2021. The General Assembly took place online. Here the restructuring of various projects and functions within EPSA were discussed. In addition, a large part of the new EPSA team was elected. The TWIN did not take place physically this year, however, there is good contact with a partner for a future edition. Moreover, an E-Twinnet was organized with medical students from Turkey, which was a great success. During the meeting with the curatorial stipendia, one heavy application was approved and the budget for the year 2020 was increased by 5000 euros. The statistics of the social media channels, which the K.N.P.S.V. uses, were presented.

Various committees were discharged and installed and various budgets were presented and approved. The settlement of the 2020-2021 board year and the budget for the 2021- 2022 board year were presented and approved. The 119th candidate board was elected.

Finally, the board transfer took place. The K.N.P.S.V. board 2020-2021 from Groningen, consisting of Ulrike van Ark, Emma van Rijn, Henrik Huizinga and Katie Remmers, gave way to the K.N.P.S.V. board 2021-2022 from Leiden, consisting of Priscilla Tan, Nicky Janssen, Thijs Revelman, Franka Hettfleisch and Jason Lin.
